We identified and registered 82 transactions in Q3

During Q3, we identified and registered 82 transactions, 10 of which occurred in the private sector. The Total Contract Value (TCV) was disclosed in 81% of the cases, ranging from €1 million to €720 million. The transaction with the highest disclosed contract value (€720 million) was the 4-year (2+1+1) Information Management Professionals secondment tender for the UWV, awarded to Circle8.

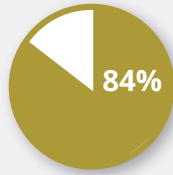
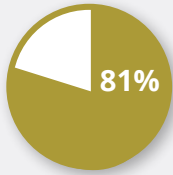
